

**Articles of Incorporation
and
Certificate of Organization**

We, whose names are hereto subscribed, do by this agreement, associate ourselves together with the intention of forming a Kansas Credit Union in accordance with Chapter 17 of the Statutes of the State of Kansas, and to hereby bind ourselves to comply with the provisions of this instrument and with all laws, rules, and regulations applicable to Credit Unions and do hereby certify as follows:

First: The name of the proposed Credit Union is _____

Second: The business office of the said Credit Union is to be located in the City of _____

Third: The name and address of said Credit Union resident agent and registered office in the State of Kansas is:

Fourth: This Credit Union is organized **not** for profit, **not** for charity, but for service and the objects and purposes to be Transacted and carried on are:

- (a) To foster economic democracy through this Credit Union.
- (b) To bring the ideal of economic freedom to our Credit Union members, to the end that the use of money be based upon the beneficial needs of members and not upon greed.
- (c) To bring those higher conceptions of a more perfect economic life which will be truly of the people, by the people, and for the people.
- (d) To promote thrift by receiving the savings of its members in payment for shares.
- (e) To make loans to members in the way and manner provided by law.
- (f) To invest the savings of its members in the way and manner provided by law.
- (g) To exercise those functions described in the laws of the State of Kansas governing Credit Unions, and to exercise all other powers granted to corporations generally which are supplemental to Credit Union law and which are not inconsistent with laws specifically applicable to Credit Unions.

Fifth: This Credit Union shall have no authority to issue capital stock.

Sixth: The par value of shares of said Credit Union shall be \$ _____.

Seventh: The number of shares shall be unlimited.

Eighth: The conditions of membership shall be fixed by the bylaws.

Ninth: The number of directors shall be five or more as fixed by the bylaws.

Tenth: The term for which this Credit Union is to exist shall be in perpetuity.

Eleventh: Organization as a Credit Union is desired in accordance with the provisions of said above described laws.
