Agenda

It was moved by Mr. Dyer and seconded by Mr. Wilmoth to approve the agenda as presented. Motion carried unanimously.

Minutes of the Previous Meeting

The minutes of the February 6, 2024, council meeting were reviewed and moved by Mr. Wilmoth and was seconded Ms. Kliewer. Motion carried unanimously.

Administrator's Report

Staff Update

- The agency has had no changes.
- We have posted the opening for an Examiner.
- The staff will receive the 5% pay raise approved by the Legislature.
- Examiner Cal Tutak will be attending the first year of the Business Lending Certification School offered by America's Credit Unions. In 2025, he will complete a year of Agricultural Lending through the University of Missouri's Extension Office. Cal also received his Certified State Credit Union Examiner (CSCUE) designation from NASCUS.
- Examiners Amanda Wilson and Debbie Johnson obtained their Credit Union Compliance Expert (CUCE) certification from America's Credit Unions.
- Examiner Jacob Bowman will attend his final STEP class in July.

Department Update

- Administrator Julie Murray and Financial Examiner Administrator Gail Bright attended the NCUA's Multi-Group Meeting in Omaha June 4-5. The meeting covered concerns NCUA is seeing: Recordkeeping; Cyber Incident Reporting; IT General Control Audits; Enterprise Risk Management, Participation Loans, and Interest Rate Risk and Liquidity
- In addition to credit union staff Elder Financial Exploitation training, Gail will now be available to assist
 credit unions with providing training for credit union members covering elder financial exploitation and
 current scams.
- The new KDCU website is in final edits, and we anticipate a July rollout.
- HB 2561 was signed by Governor Laura Kelly and will become effective July 1, 2024.

Credit Unions on Monthly Reporting

- There are currently 11 credit unions on monthly reporting to KDCU. The number of credit unions on monthly reporting has decreased by two since the February 2024 Council Meeting.
- A credit union on monthly reporting sends their report to KDCU. The report is reviewed, and a copy is forwarded to the examiner assigned to the credit union. The examiner uses the report to monitor the credit union.

Credit Union Condition Report

• 34 out of 45 credit unions have "1" and "2" ratings. This indicates 76% of the total number credit unions have satisfactory or above performance.
